CAROL JOY HOLLING CAMP FUNCTIONS AS NLOM'S FLAGSHIP CAMP, CONFERENCE, AND RETREAT CENTER, CONVENIENTLY LOCATED NEAR EUGENE T. MAHONEY STATE PARK, WHILE SULLIVAN HILLS CAMP SERVES CAMPERS AND RETREAT GUESTS THROUGHOUT THE WESTERN REGION.

EACH YEAR, NLOM WELCOMES APPROXIMATELY 1,600 SUMMER CAMPERS AND MORE THAN 18,000 RETREAT AND CONFERENCE GUESTS. DURING THE SUMMER MONTHS, ITS PROGRAMS PRIMARILY SERVE SCHOOL-AGE YOUTH AND INDIVIDUALS WITH DISABILITIES. THROUGHOUT THE YEAR, NLOM HOSTS CHURCHES, SCHOOLS, BUSINESSES, NONPROFITS, AND COMMUNITY ORGANIZATIONS FOR RETREATS, CONFERENCES, AND LEADERSHIP DEVELOPMENT EXPERIENCES.
